Americans With Disabilities Act (ADA) Transition Plan

I. Background of ADA Requirements

The Americans with Disabilities Act of 1990 and the amendment, Americans with Disabilities Act of 2008, are Federal legislative laws that prohibit the discrimination of those with disabilities. The original law was then rearranged and published in the United States Code. The current version of this code is broken into four sub-chapters as listed below:

- A. Title I Employment
- B. Title II Public Services
- C. Title III Public Accommodations and Services Operated by Private Entities
- D. Title IV Miscellaneous Accommodations

This Transition Plan deals with Title II – Public Services. Title II states that no qualified individual with a disability shall, on the basis of disability, be excluded from participation in or be denied the benefits of the services, programs, or activities of a public entity, or be subjected to discrimination by any public entity. CFR 35.105 requires that the City of Ripley perform a self-evaluation of its public services in order to determine if these facilities are accessible to those with disabilities. As part of this self-evaluation, the City held a public hearing, on February 7, 2012, to receive input and complaints from the public about areas of concern. The City hired Cook-Coggin Engineers to perform the Self Evaluation of the Rights-of-Way of the city streets and to develop the Transition Plan for the City.

II. ADA Program

A. Responsible Official

The Disability Services Coordinator has been designated as the City Clerk, currently Tracy Luna. This person is responsible for the implementation of the City's ADA Transition Plan.

B. Public Review

In the event that structural changes to facilities will be undertaken to achieve program accessibility, a public entity that employs 50 or more persons shall develop a transition plan setting forth the steps necessary to complete such changes. A public entity shall provide an opportunity to interested persons, including

individuals with disabilities or organizations representing individuals with disabilities, to participate in the development of the transition plan by submitting comments. A copy of the transition plan shall be made available for public inspection.

The City placed an advertisement in the local newspaper for all citizens to voice their concerns and recommendations for how the transition plan will be developed.

C. Self Evaluation

As required by the ADA legislation, the City of Ripley hired Cook Coggin Engineers, Inc. to conduct a self evaluation of its programs, services, and activities, within the rights-of-way, to ensure that they are accessible and usable by persons with disabilities. The findings from the self evaluation are part of the Transition Plan(Appendix A), in which architectural barriers are addressed and a timeline for correction is established.

D. Grievance Procedure

The City of Ripley has developed a disabled access complaint procedure for individuals who have an ADA issue with regard to program or facility access. The complaint form (Appendix B) is on file at the Ripley City Hall.

III. Transition Plan

The self-evaluation was conducted to provide the information needed in successfully completing the Transition Plan addressed in 28 CFR 35.150 (d). If a public entity has responsibility or authority over streets, roads, or walkways, its transition plan shall include a schedule for providing curb ramps or other sloped areas where pedestrian walks cross curbs, giving priority to walkways serving entities covered by the Act, including State and local government offices and facilities, transportation, places of public accommodation, and employers, followed by walkways serving other areas. The transition plan at a minimum must include the following information:

- 1. Identify physical obstacles that limit the accessibility of the public entity's programs, services or activities to people with disabilities.
- Describe the methods to be used to make the facilities accessible.
- 3. Provide a yearly schedule for making the access modifications.

A. Barrier Removal and compliance strategies for public rights-of-way

The self-evaluation of the rights-of-way determined that the inadequacies are physical barriers. Therefore, a 15-year plan has been established for all rights-of-way to be ADA compliant, where permissible. The primary accessibility improvements are:

1. Curb Ramps and Sidewalk Ramps

The main obstacle for the City to be ADA compliant is the lack of ramps. At the self-evaluation walk through of all the streets with sidewalks, 89 grade changes from the sidewalk to the street were observed without curb ramps and 25 grade changes in the sidewalk without a properly sloped ramp. Every grade change was recorded in a Geographical Information System (GIS) mapping system that will show precise location as well as a picture of the sidewalk. This mapping system was used to create this transition plan.

Priorities for the construction of ramps will be from the town square that is most heavily used and then proceed out into the surrounding areas. See the Appendices C and D.

Not all areas of grade change will have curb ramps scheduled to be added in this transition plan due to site-specific situations that will not allow for ADA compliant curb ramps. However, most of these cases have sidewalk on both sides of the road so the entire route will be accessible but may require moving to the other side of the road.

2. Sidewalk Repair Work

Another large area of concern is the deterioration of the existing sidewalk. Throughout the city's system of sidewalk are multiple areas that are in need of repair. Again, all areas have been located and 84 areas for sidewalk repair have been noted.

Priorities for the repair of sidewalk will be from the town square that is most heavily used and then proceed out into the surrounding areas. See the Appendices C and D.

3. Sidewalk Obstruction

The last area of concern involves obstructions in the sidewalks. ADA requires that a minimum of 36 inch clear space be provided for sidewalks. There are eleven areas

where the sidewalk is not compliant due to power poles, shrubs, garbage cans, ect., that impede on this 36 inch that need to be corrected.

Priorities for the removal of obstructions will be from the town square that is most heavily used and then proceed out into the surrounding areas. See the Appendices C and D.

All sidewalk repairs shall be compliant with the current ADA standards. Current standards can be found at www.ada.gov/regs2010/2010ADAStandards/2010ADAStandards.htm.

NOTICE UNDER THE AMERICANS WITH DISABILITIES ACT

In accordance with the requirements of title II of the Americans with Disabilities Act of 1990 ("ADA"), the **City of Ripley** will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs, or activities.

Employment: The City of Ripley does not discriminate on the basis of disability in its hiring or employment practices and complies with all regulations promulgated by the U.S. Equal Employment Opportunity Commission under title I of the ADA.

Modifications to Policies and Procedures: The City of Ripley will make all reasonable modifications to programs to ensure that people with disabilities have an equal opportunity to enjoy all of its programs, services, and activities. For example, individuals with disabilities will be able to use the sidewalks throughout the city due to added curb ramps and repairs to broken areas.

The ADA does not require the **City of Ripley** to take any action that would fundamentally alter the nature of its programs or services, or impose an undue financial or administrative burden.

Complaints that a program, service, or activity of the **City of Ripley** is not accessible to persons with disabilities should be directed to *Tracy Luna*, *ADA Coordinator*.

The **City of Ripley** will not place a surcharge on a particular individual with a disability or any group of individuals with disabilities to cover the cost of providing auxiliary aids/services or reasonable modifications of policy, such as retrieving items from locations that are open to the public but are not accessible to persons who use wheelchairs.

Grievance Procedure under The Americans with Disabilities Act

This Grievance Procedure is established to meet the requirements of the Americans with Disabilities Act of 1990 ("ADA"). It may be used by anyone who wishes to file a complaint alleging discrimination on the basis of disability in the provision of services, activities, programs, or benefits by the **City of Ripley**. The City of Ripley's Personnel Policy governs employment-related complaints of disability discrimination.

The complaint should be in writing and contain information about the alleged discrimination such as name, address, phone number of complainant and location, date, and description of the problem. Alternative means of filing complaints, such as personal interviews or a tape recording of the complaint, will be made available for persons with disabilities upon request.

The complaint should be submitted by the grievant and/or his/her designee as soon as possible but no later than 60 calendar days after the alleged violation to:

Within 15 calendar days after receipt of the complaint, *Tracy Luna* will meet with the complainant to discuss the complaint and the possible resolutions. Within 15 calendar days of the meeting, *Tracy Luna* will respond in writing. The response will explain the position of the **City of Ripley** and offer options for substantive resolution of the complaint.

If the response by *Tracy Luna* does not satisfactorily resolve the issue, the complainant and/or his/her designee may appeal the decision within 15 calendar days after receipt of the response to the **Mayor of Ripley**.

Within 15 calendar days after receipt of the appeal, the **Mayor of Ripley** will meet with the complainant to discuss the complaint and possible resolutions. Within 15 calendar days after the meeting, the **Mayor of Ripley** will respond in writing, and, where appropriate, in a format accessible to the complainant, with a final resolution of the complaint.

All written complaints received by *Tracy Luna*, appeals to the **Mayor**, and responses from these two offices will be retained by the **City of Ripley** for at least three years.
